Promotion Period	16:00PM to 19:00PM Every Friday from 01.05.2026 until 30.04.2027
Eligible entrants	Australian residents who are aged 18 years or older. Directors, management and employees of the Promoter and their immediate family are not permitted to enter. Persons who are barred or excluded from relevant parts of the venue to which the promotion applies or the whole venue are not eligible to enter.
Purchase of Product	Any Food or Beverage items purchased between 16:00 – 19:00 receive 1 entry/ticket into the draw.
The Prize	Starting Jackpot \$300. \$90 added to the prize pool weekly until Joker found.
Total prize value	Cash up to \$4980 Jackpot (\$300 Starting pot + \$90 added for each week joker not selected)
Total number of prizes	1 – Determined when the Joker is selected.
Method of entry	One ticket is awarded with any purchase of any food or beverage product during the Promotion Period Each week, the drawn participant is required to attend in person and exercise their judgment in selecting one card from the remaining face-down cards on the game board. As cards are permanently removed from the board following each round in which the Joker is not revealed, the composition of the remaining field changes progressively. If the card is the Joker, the Eligible entrant will win the Jackpot at its given time, If the Eligible entrant does not pick the Joker, the prize will jackpot and increase by \$90 for the following draw.
